Eligibility Criteria And Conditions Of Appointment

- 1) Must be at least 18 years of age.
- 2) Undischarged bankrupts are ineligible to serve as members.
- 3) Expected to commit the time required to perform board and committee duties. Minimum time commitment is on average 5 to 10 hours per month. Committee membership may require additional time commitment.
- 4) Must fulfill the requirements and responsibilities of the role – for example, preparing for and attending meetings, upholding fiduciary obligations and working cooperatively and respectfully with colleagues. Must comply with legislation governing the organization, the organization's by-laws and policies, and all other applicable rules.
- 5) Board members must sign a declaration confirming their agreement to adhere to their fiduciary duties, board and corporate policies.

All Board and Committee Members must avoid conflicts between their self-interest and their duty to the organization. Board Policy 2.9 clearly defines and provides examples of conflicts of interest.
